Re: QSP 2024-2 On-Call Tree Services

This Addendum modifies and forms a part of the Bid Set documents dated January 31, 2024.

This Addendum consists of the following: Two (2) typed pages and a Revised Form for General Bid (3 pages).

Where any items called for in the bid documents are supplemented here, the supplemental requirements shall be considered as added thereto. Where any original item is amended, voided, or superseded here, the other provisions of such items not specifically amended, voided, or superseded shall remain in effect.

THE NUMBER OF THIS ADDENDUM MUST BE ENTERED IN THE APPROPRIATE SPACE PROVIDED ON "GENERAL BID FORM."

Answers to Bidder's Questions:

- Question: Can you provide a copy of the last three years' bid results?
 Answer: Bids for this service have never been solicited in the past. This is the first year.
- 2. **Question**: "Method of Measurement" are these measurements Diameter or Circumference? Where are the measurements taken? Industry standard would be "DBH" Diameter Breast Height.

Answer: Measurements are Diameter and shall be taken using the "DBH" Diameter Breast Height.

3. Question: Response Time, "Under the definition of this clause, an emergency rate shall only be applicable to the first 24 hours after the Contractor has been notified." How would this apply to an ongoing or an emergency situation which requires more than 24hrs of response? After 24 hrs. of response would we have 5 days to schedule the remainder of the work at non-emergency rates?

Answer: The intent is that remediation of the immediate emergency or safety issue will be addressed within the 24-hour period. Associated work to complete the project



which would be a non-emergency, can be scheduled with a designee of the authority and billed at the non-emergency rate.

- 4. Queston: Traffic Control, "On heavily traveled roadways, a traffic officer shall be utilized to safely direct traffic through the work area. The traffic officer will be provided and paid for by the Contractor. The decision as to the locations where traffic officers will be utilized will be made solely by the Authority after consultation with the Contractor. The Contractor shall organize his work in such a manner to group together work locations that may require an officer to best utilize the officer's time and avoid the necessity of paying for hours not worked due to the guaranteed minimum hours requirement of the officers". Does the contractor pay for police details and/or flaggers? This paragraph is worded in a manner that sounds like the intention is for Lowell Housing Authority to provide the police details and/or flaggers. Does the Lowell Housing Authority have their own police officers to provide, or would Lowell police have the final call as to when officers are required?

 Answer: On the rare occasion a police detail is needed, the housing authority will contact, hire and pay the police.
- 5. **Question:** On items 109 and 110 do you mean height, not diameter? If not, that would mean you are looking at pricing for trees that are 6'-12' wide and 12-19' wide? I just want to make sure that is accurate. Also, a 10" diameter and 36" diameter tree is a very different cost and labor breakdown, but you are only asking for pricing of 36" and under.

Answer: It refers to diameter; however, the ranges have changed and are reflected in the revised bid price sheet attached to this addendum. Revisions to line item #'s 107-116.

6. **Question**: Could you be more specific on the number of trees that will be closer to 36" and closer to 10"?

Answer: This contract is for on-call as needed throughout the agency.
